#### **October Speaker**

Our October speaker, **Dr. R. Fred Ruhlman**, who currently serves as an adjunct professor of history at the University of Tennessee at Chattanooga will speak on **Captain Henry Wirtz.** 

Upon his discharge from the U. S. Navy, Dr. Ruhlman became the youngest State Trooper in Georgia. After receiving his degree in accounting and economics, Fred served a twenty-one year career as a Special Agent with the FBI working as a criminal investigator and in foreign counterintelligence. Upon retirement from the FBI and subsequent private enterprise endeavors, Fred, a self described "closet historian", then completed his Masters Degree and PhD in American Civil War Studies with honors at American Military University.

Fred's presentation will provide an analysis that will aid Round Table members in reaching their own conclusions about the infamous prison warden and his stint at the most notorious Confederate prison – was he a martyr or murderer?
